

Legal Notice

In compliance with the duty of information contained in Article 10 of Law 34/2002 of July 11, Services of the Information Society and Electronic Commerce, we inform you that the Website and the Internet portal www.arogreen.com (hereinafter, the "Web") is owned by Arogreen, SL, established in Compositor Verdi, 84 with CIF No. B675023540. The present legal notice regulates the conditions of use of the mentioned Internet portal.

Applicable law and jurisdiction
